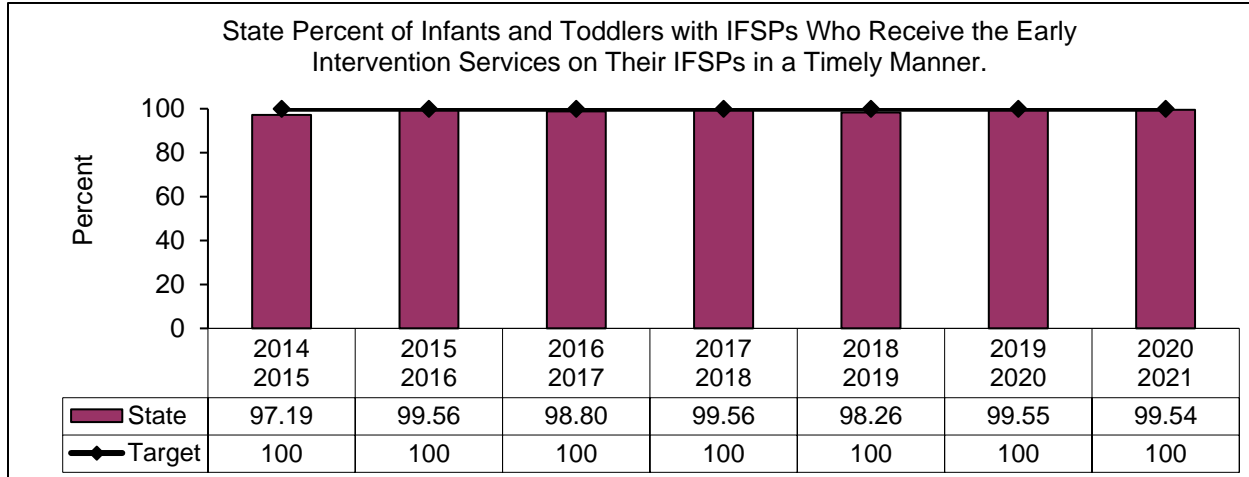

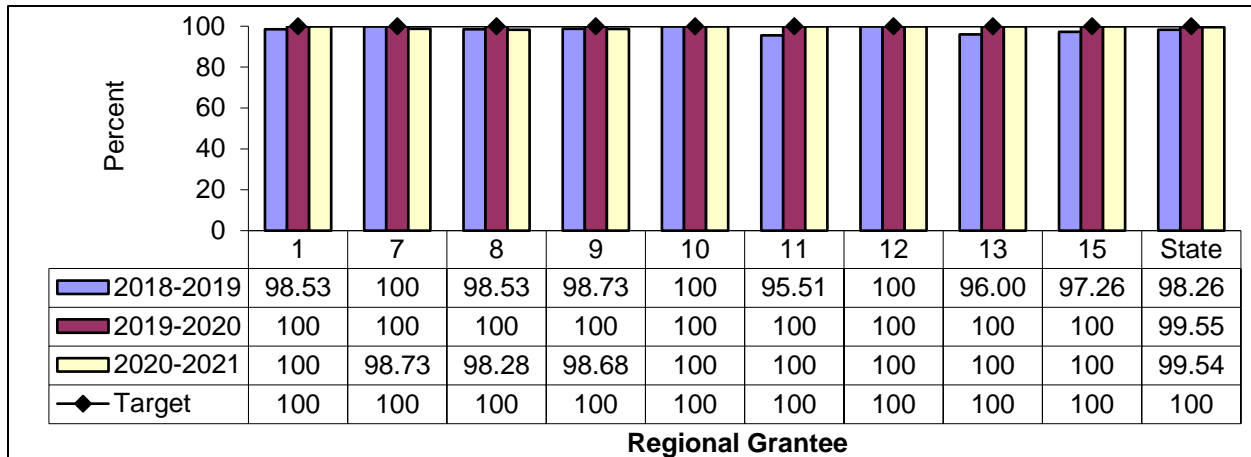

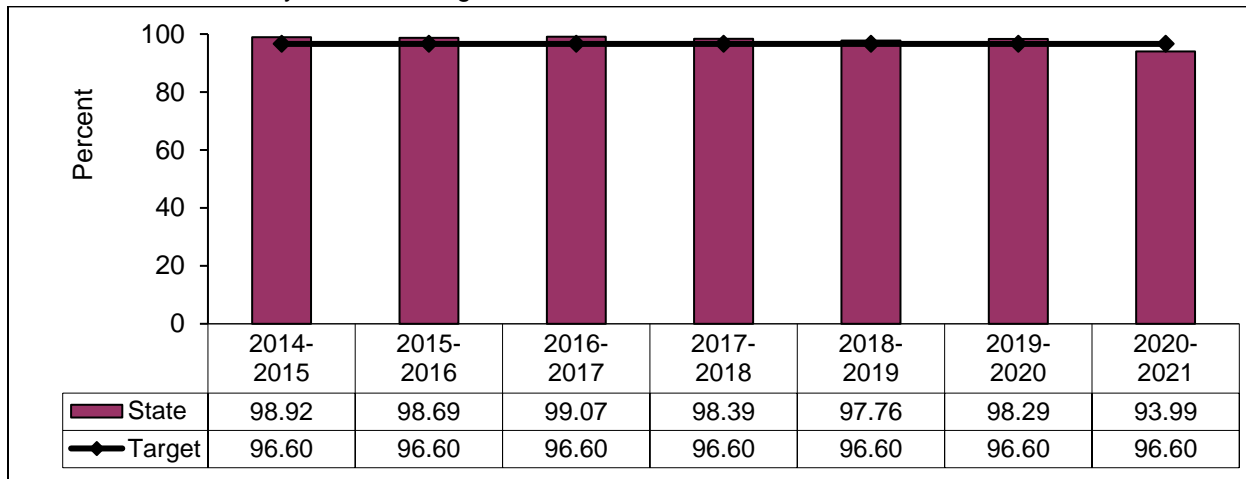

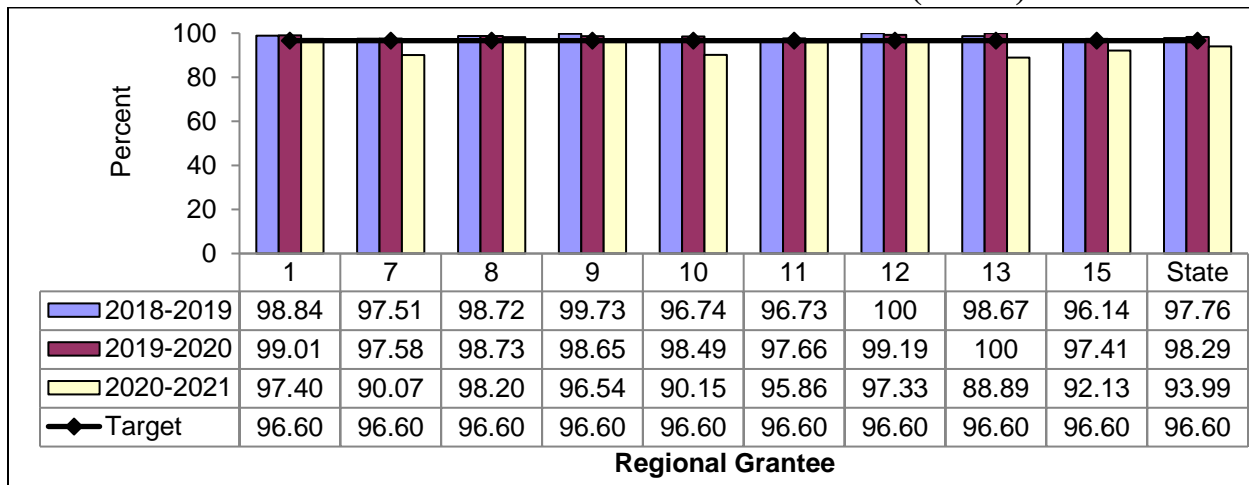

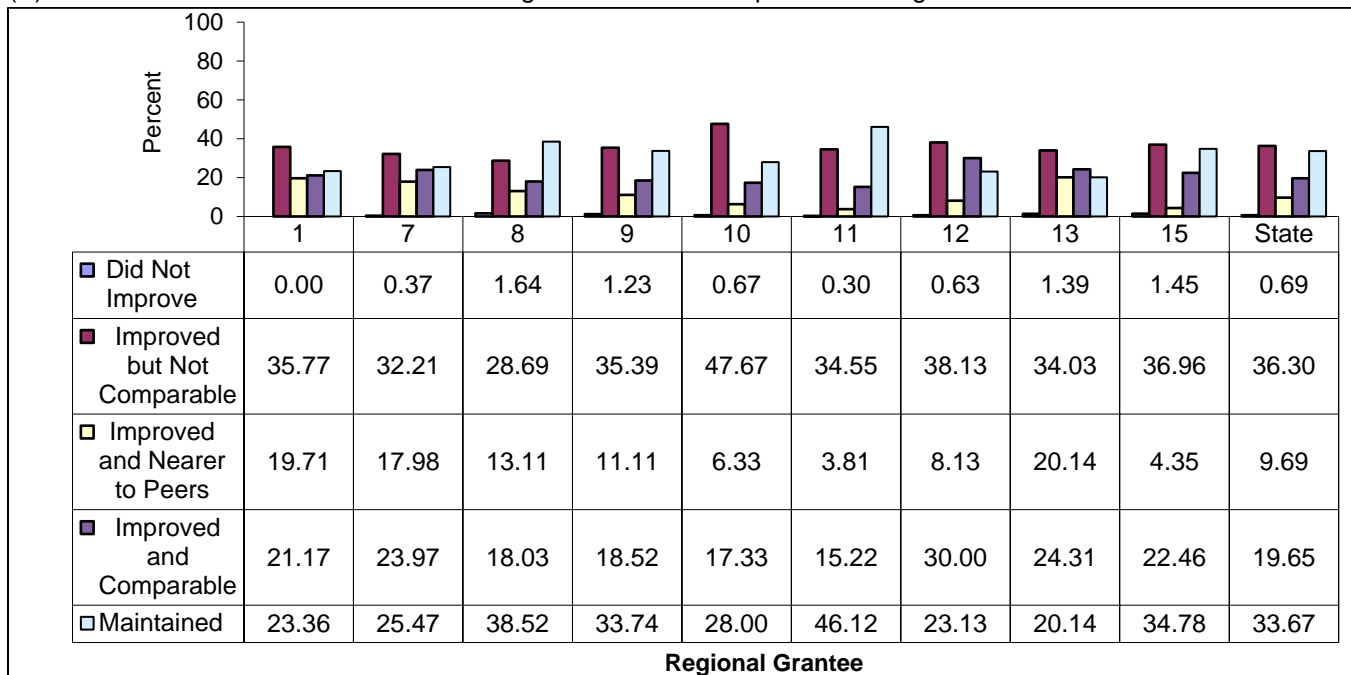

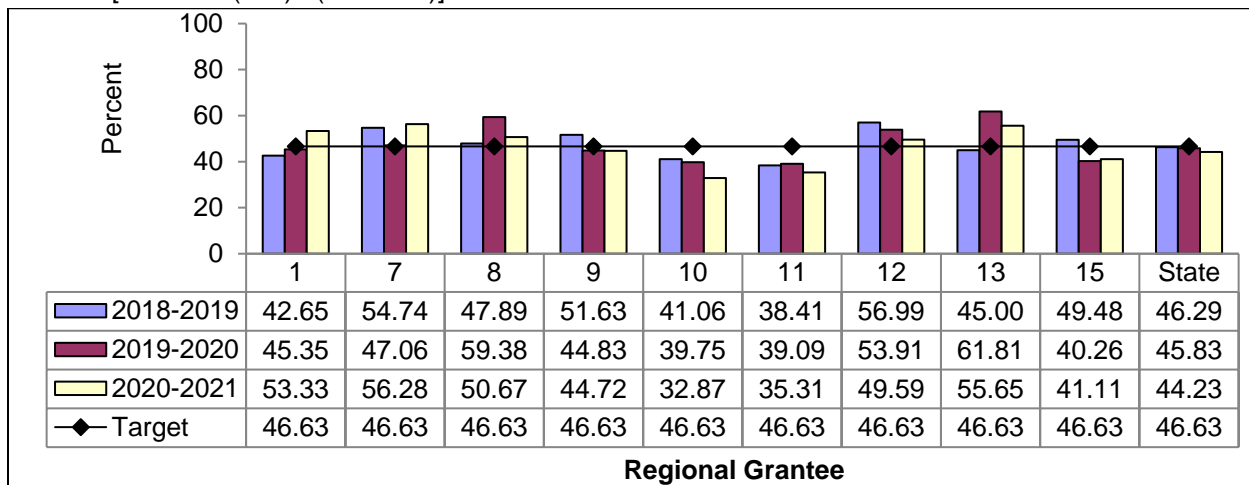

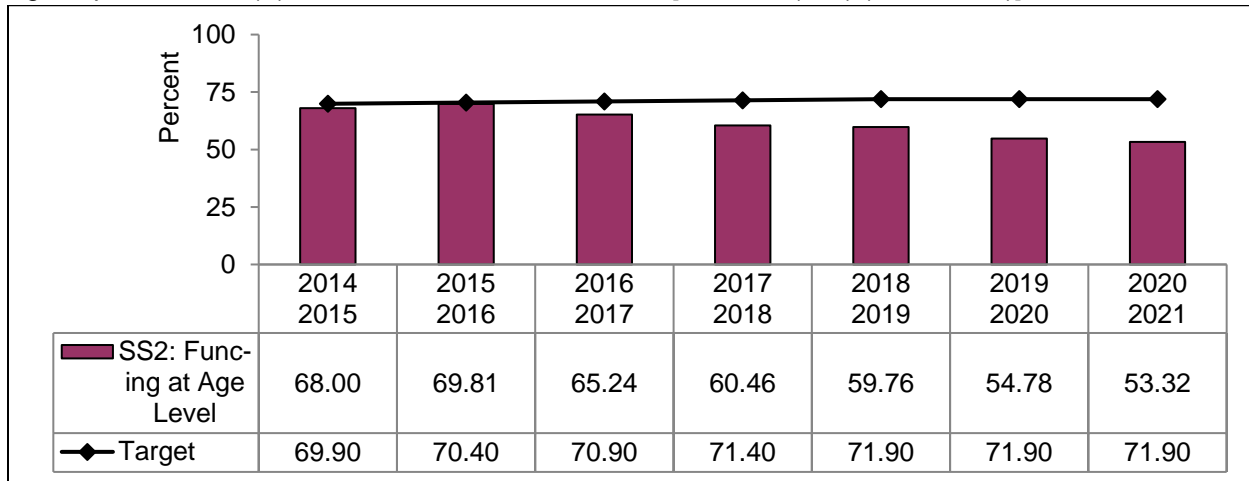

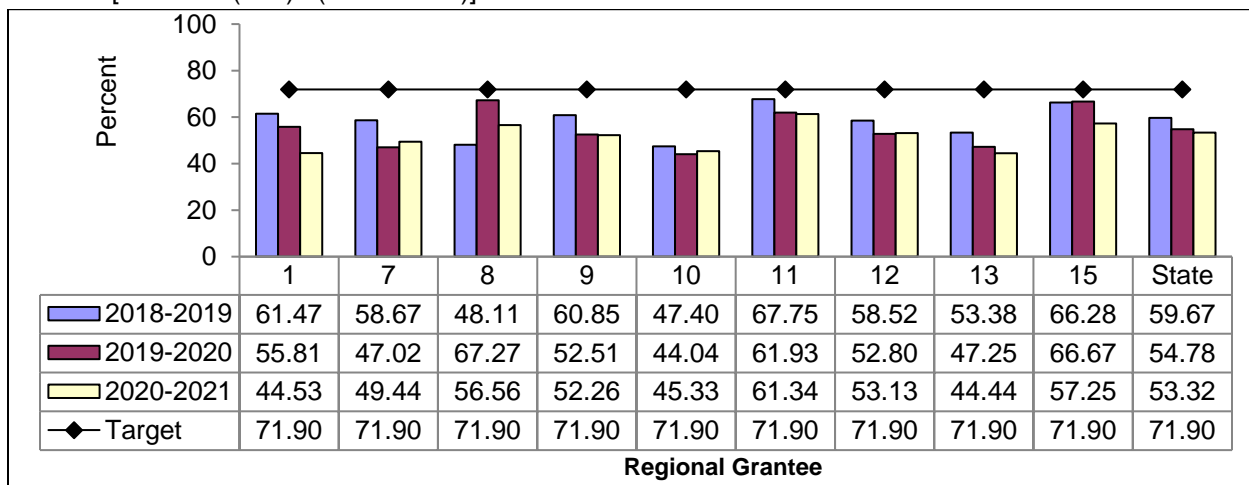

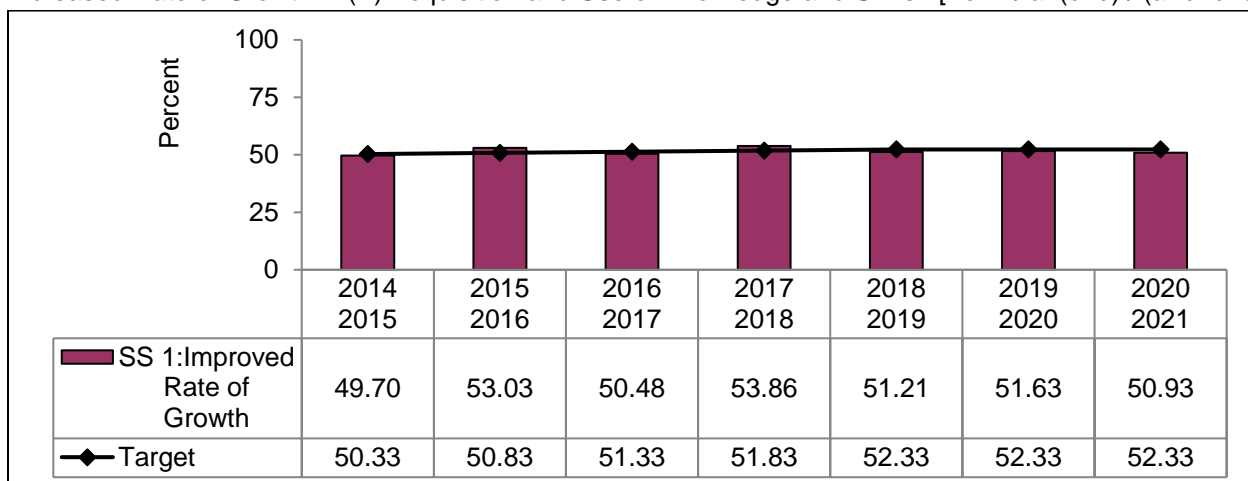

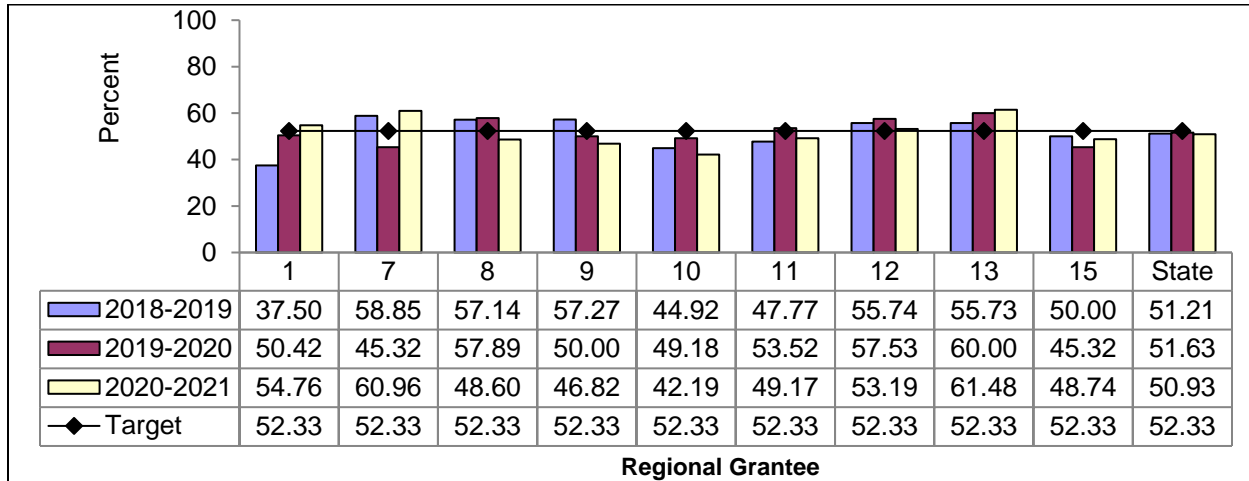

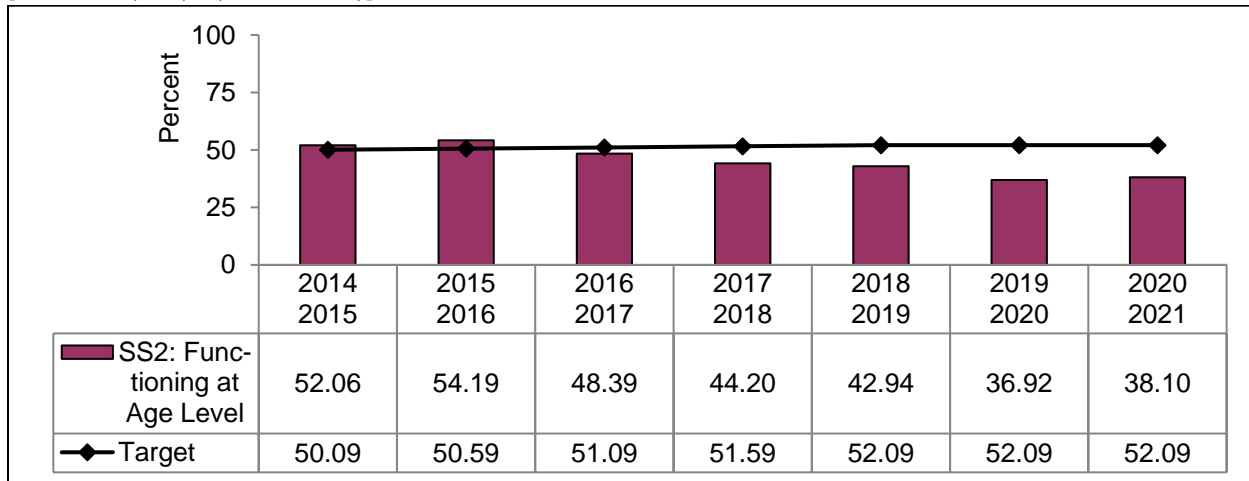

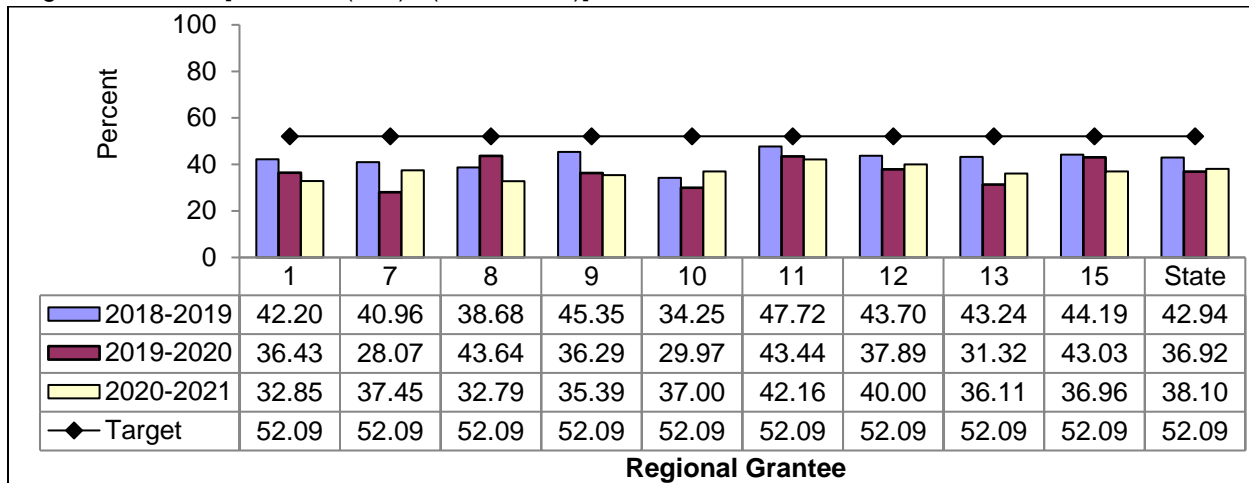

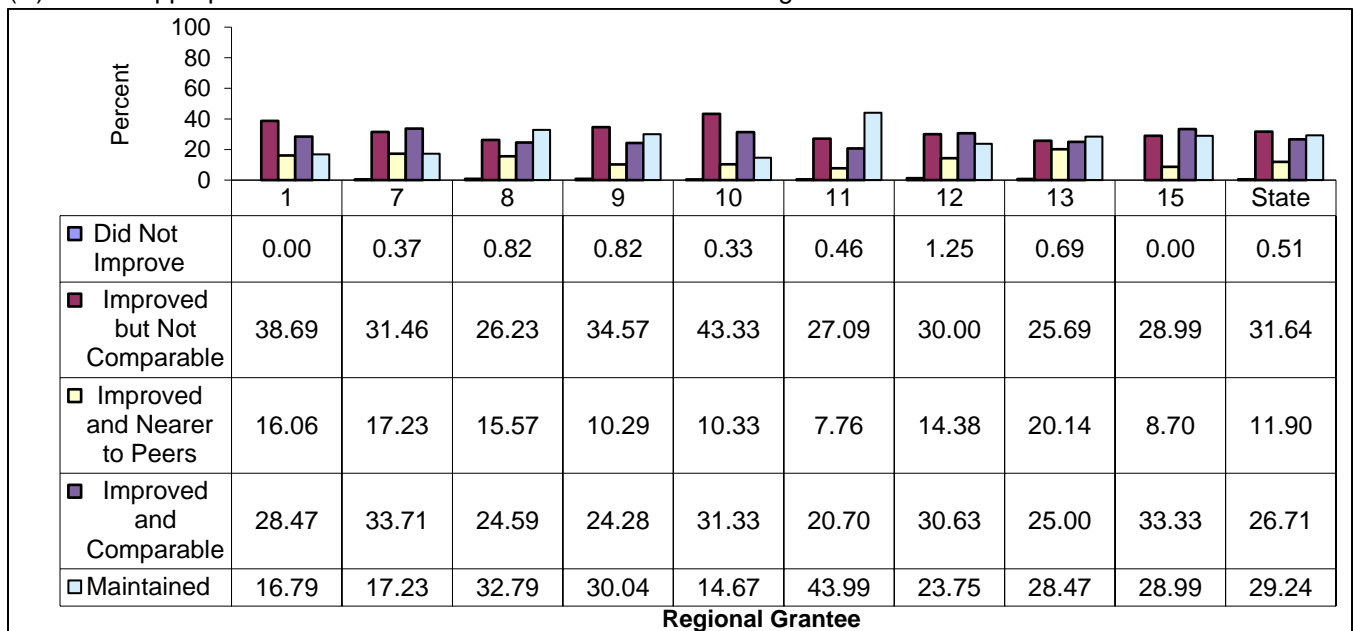

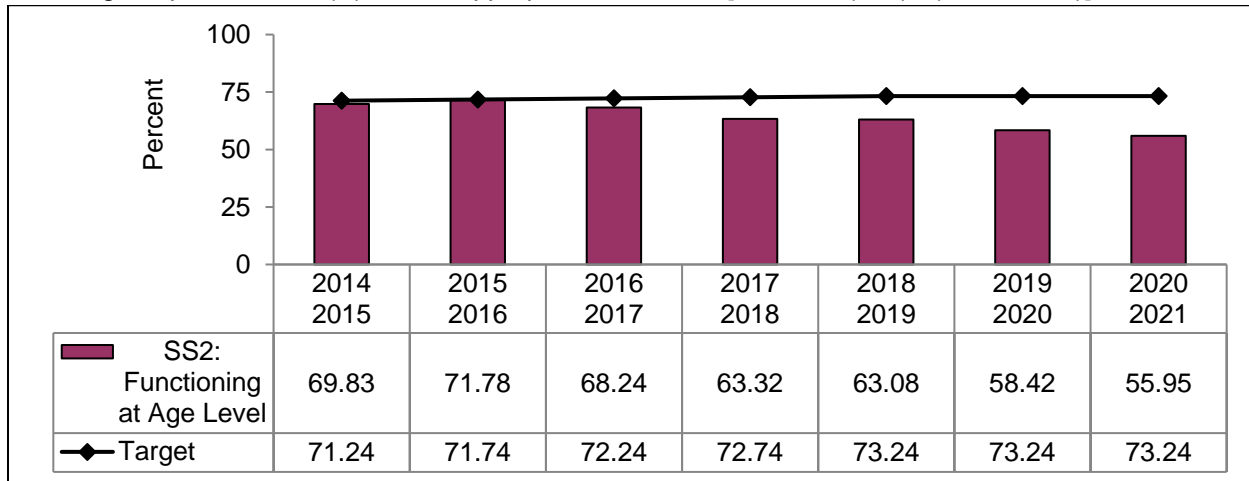

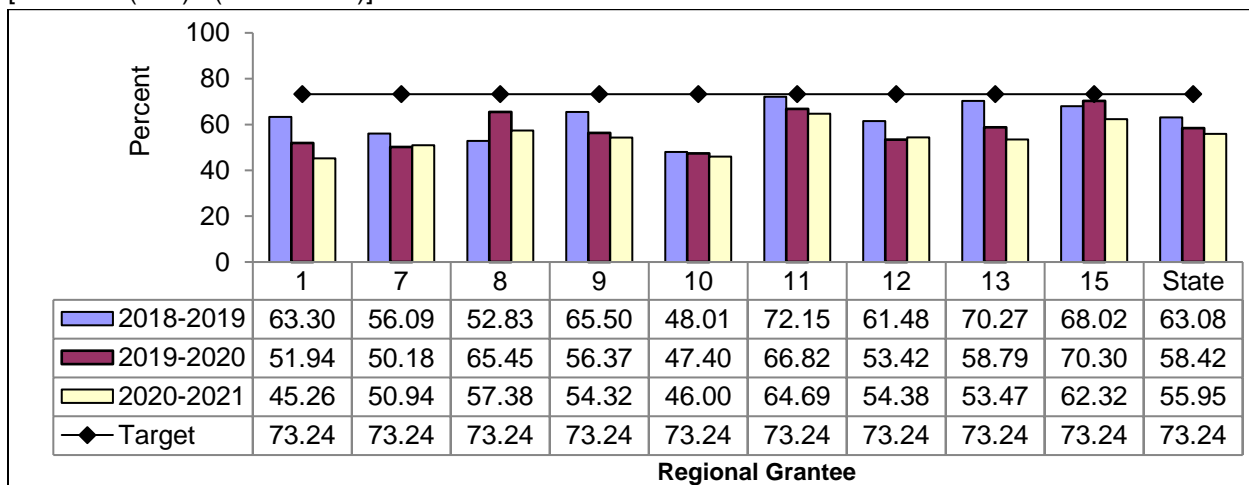

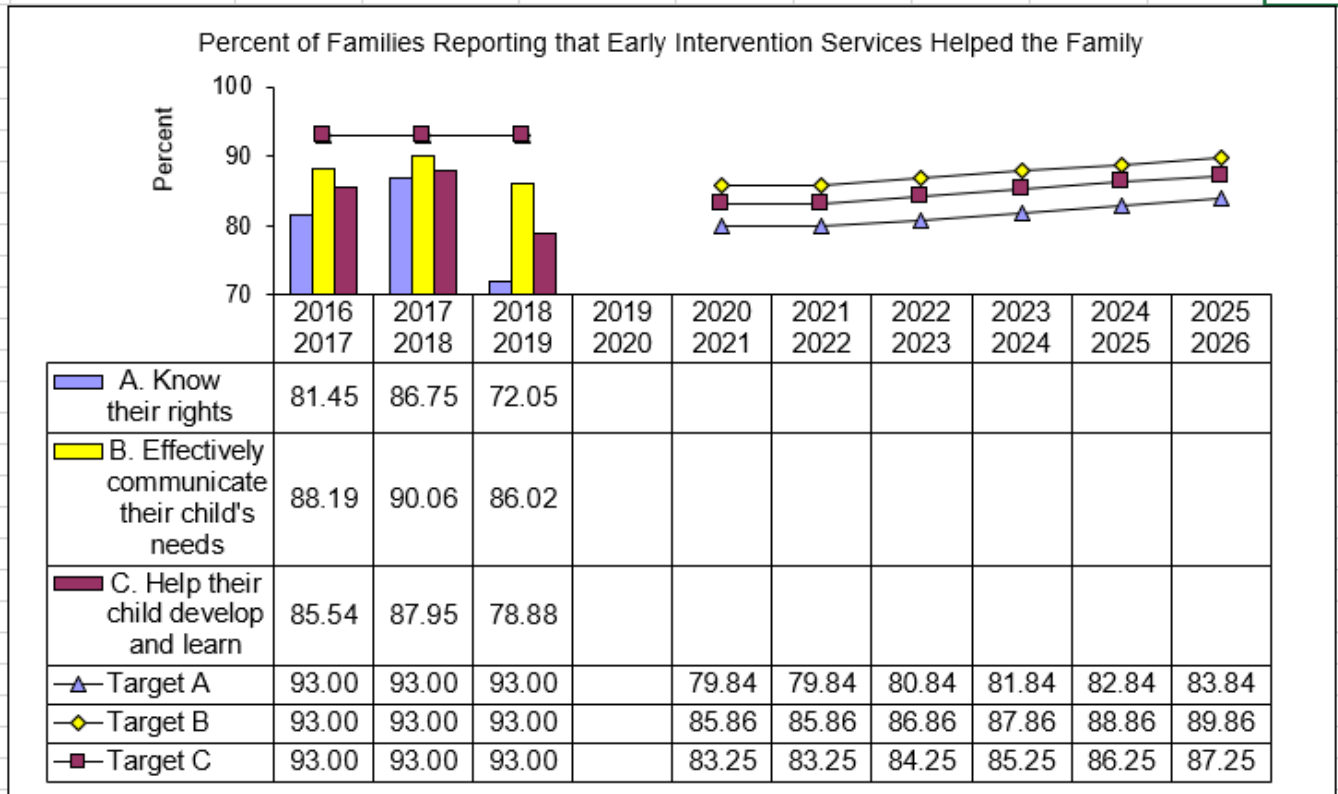

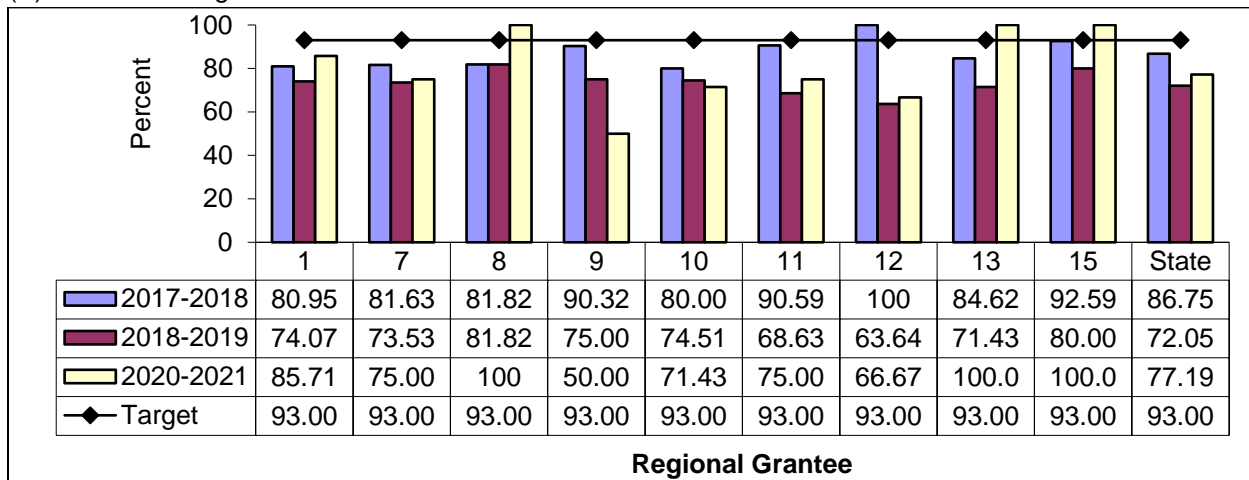

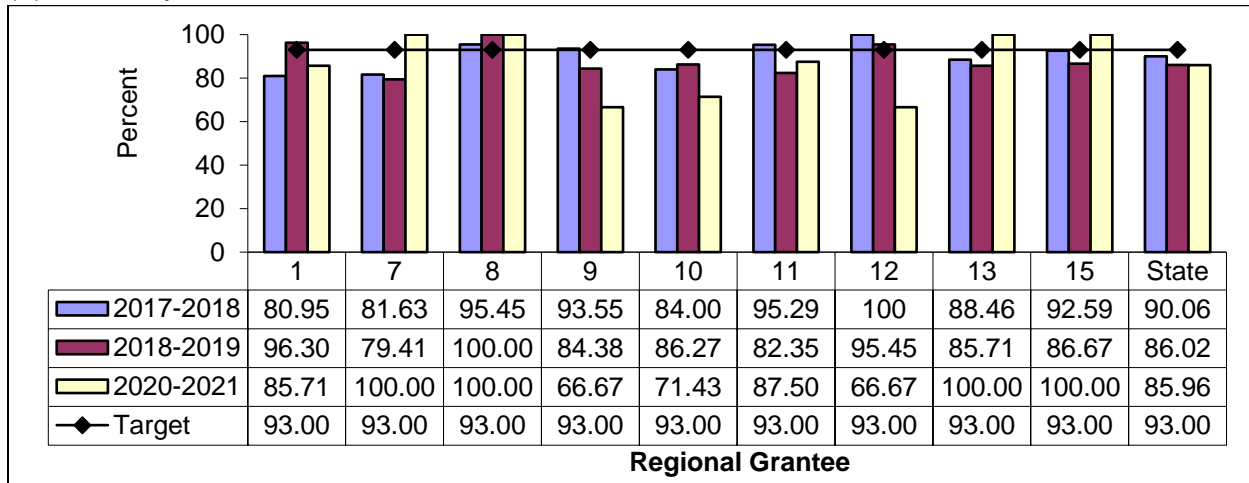
**Indicator C4A:** Regional Grantee Data for Percent of Families Reporting that EIS Helped the Family

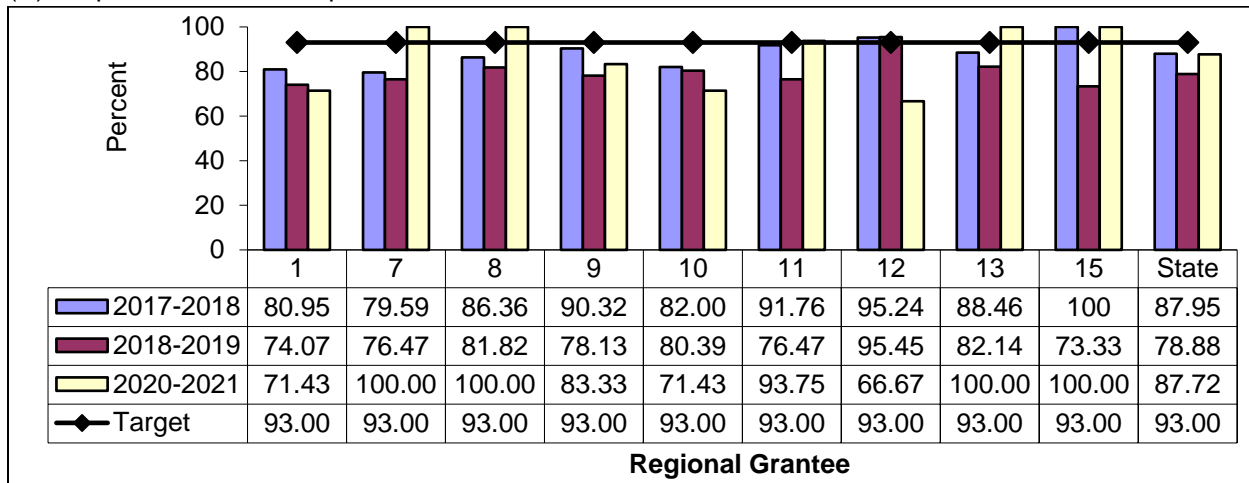

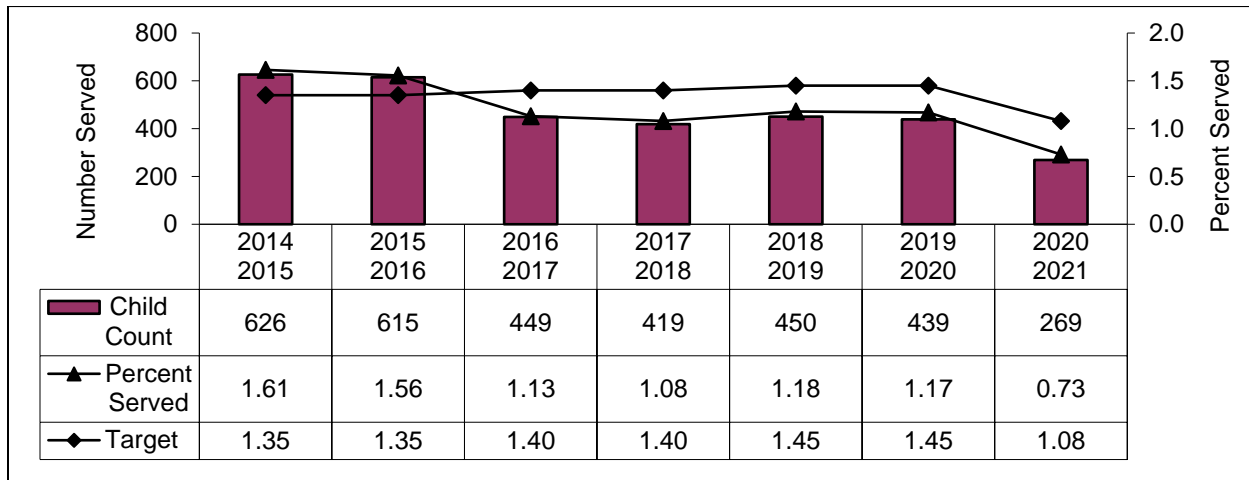

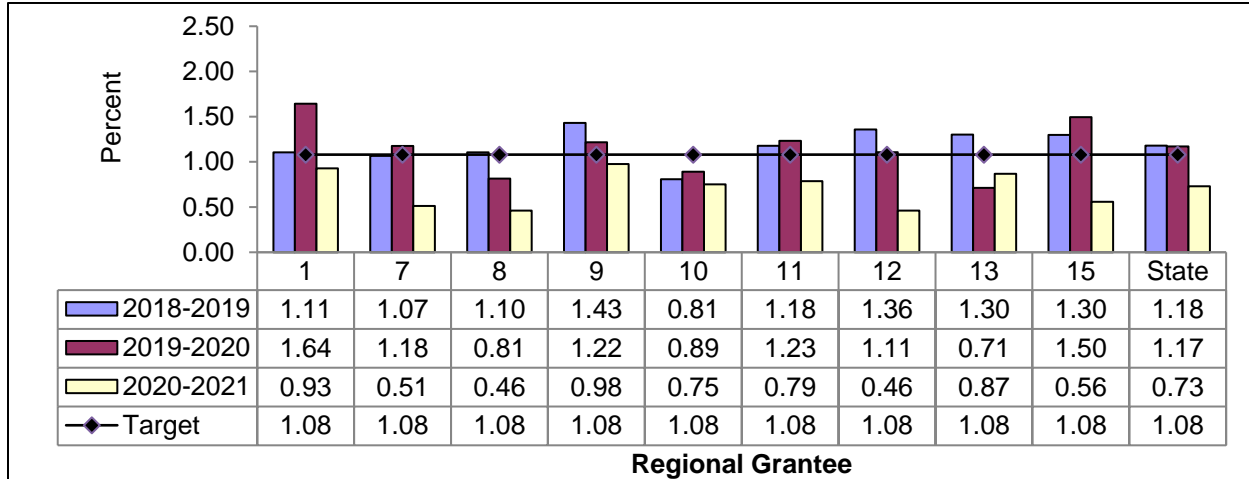
**Indicator C5:** Number and Percent of Infants Birth to One with IFSPs.

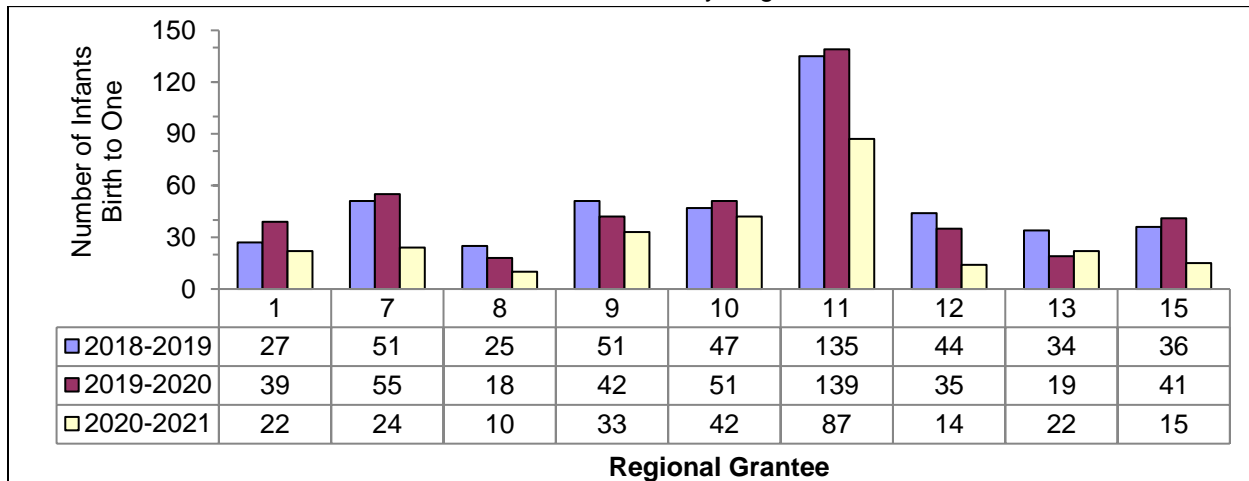

**Indicator C5:** Percent of Infants Birth to One with IFSPs, by Regional Grantee.



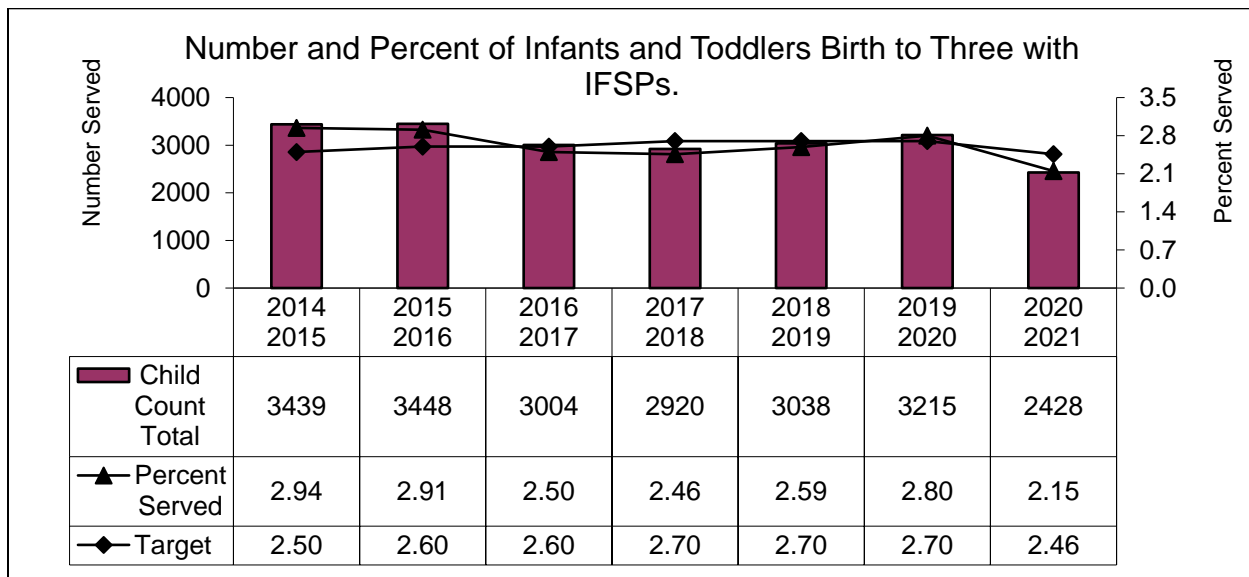

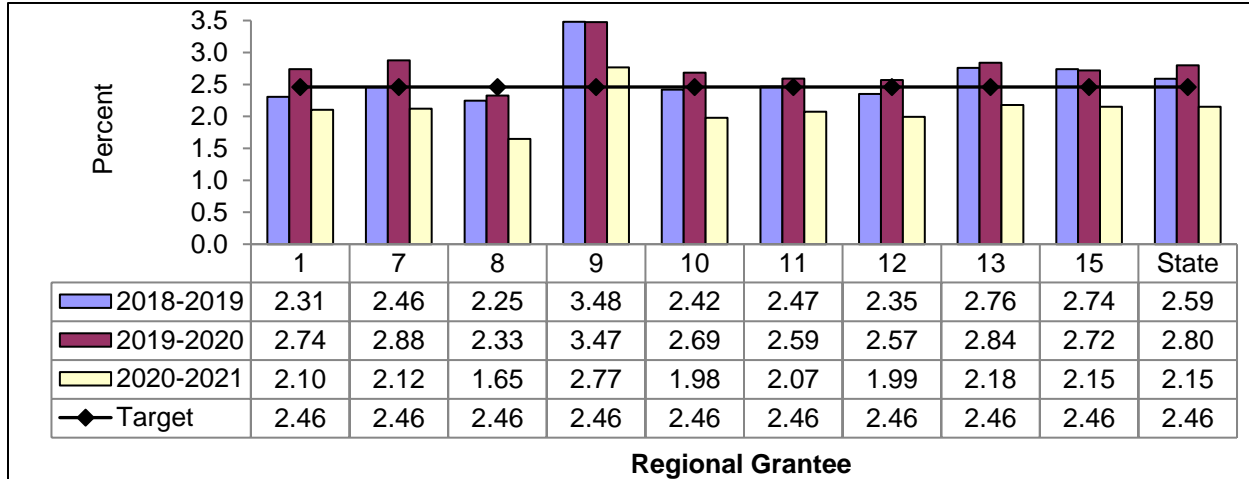
**Indicator C6:** Number and Percent of Infants and Toddlers Birth to Three with IFSPs.

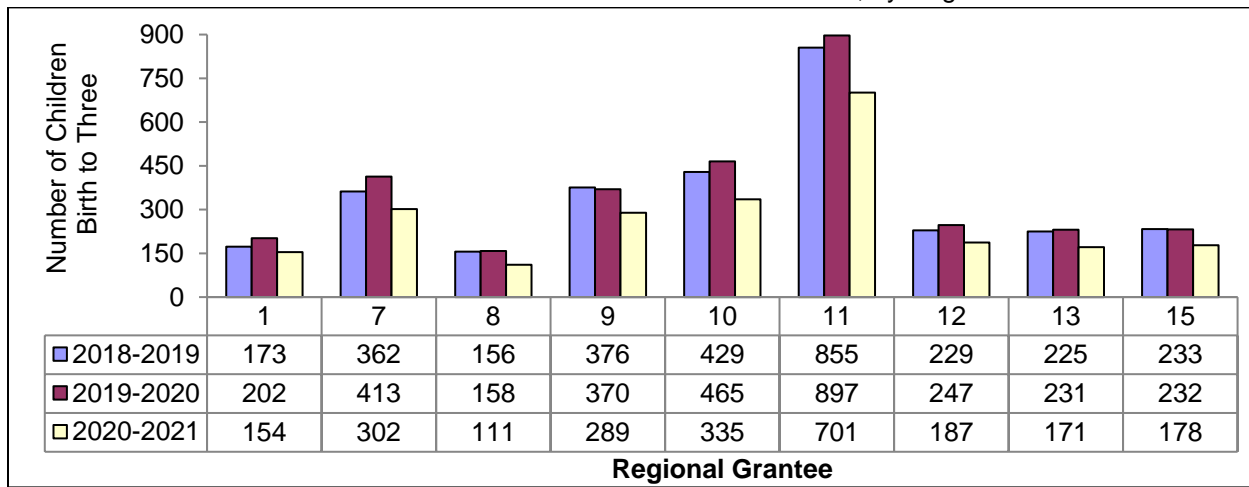

**Indicator C6:** Percent of Infants and Toddlers Birth to Three with IFSPs, by Regional Grantee.



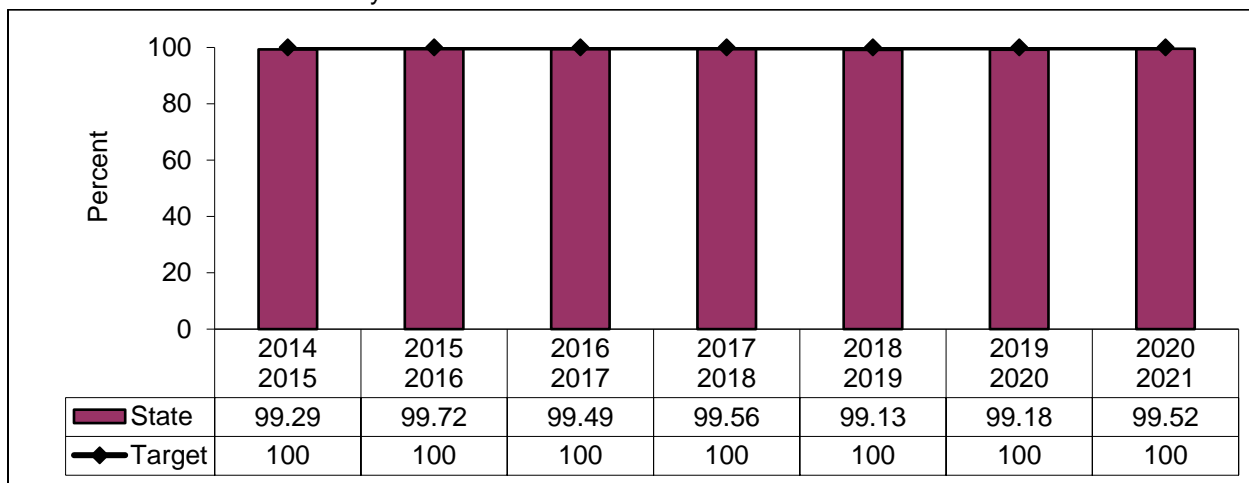

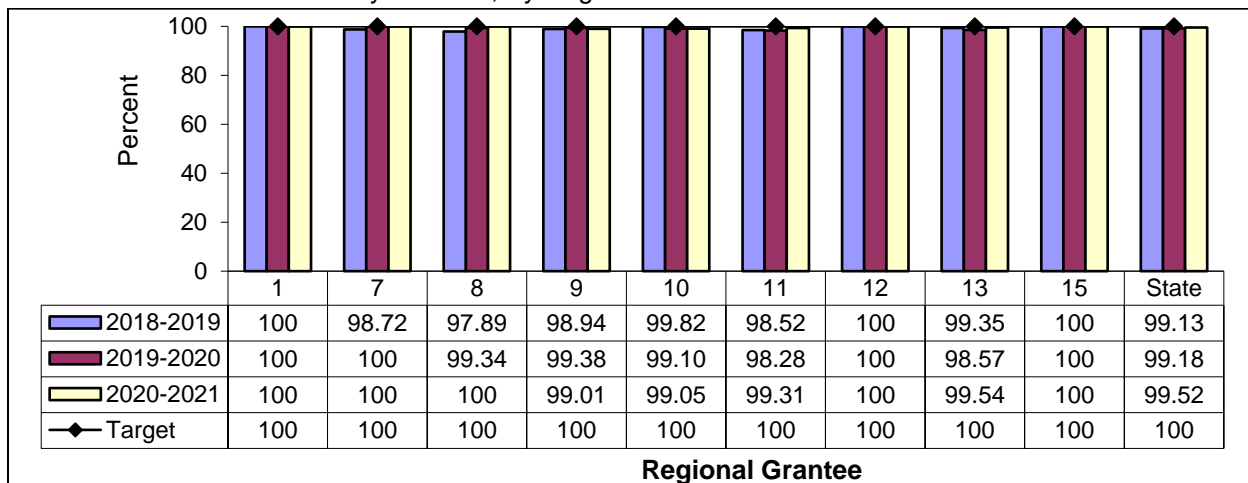

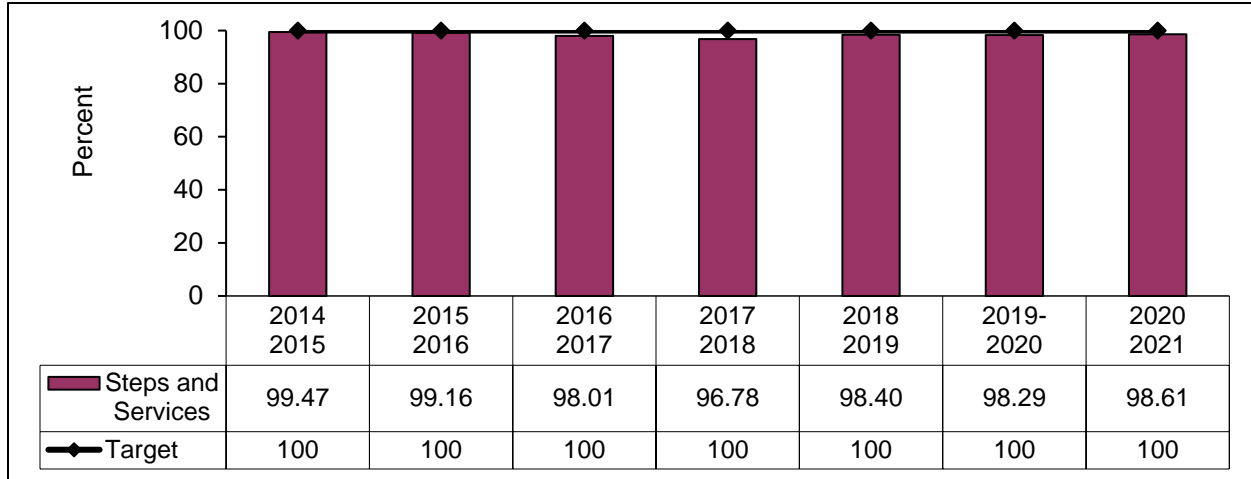

**Indicator C8A:** Percent of Children Exiting Part C Who Received Timely Transition Planning Including (A) Transition Steps and Services.



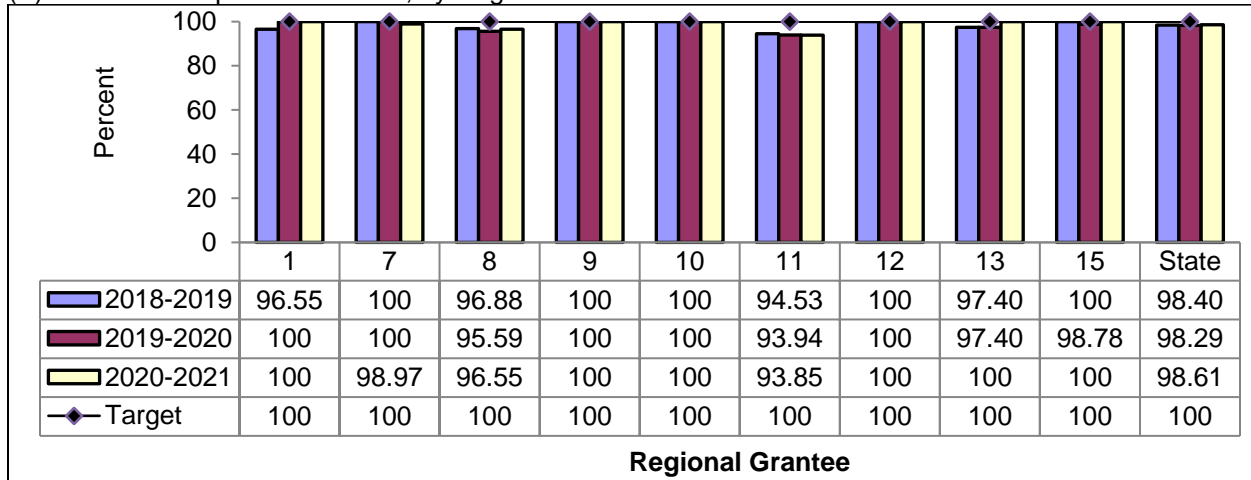

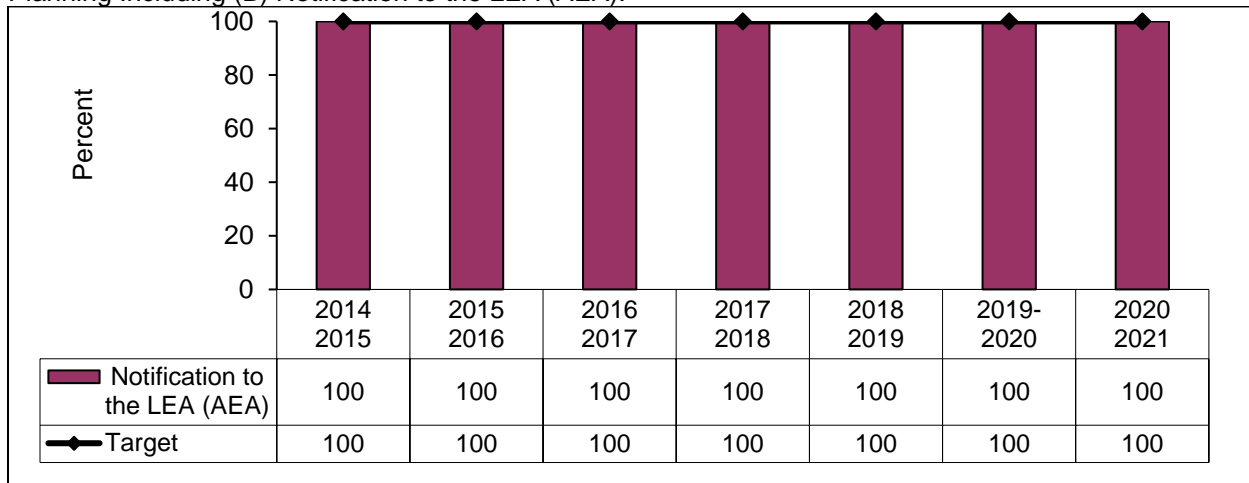

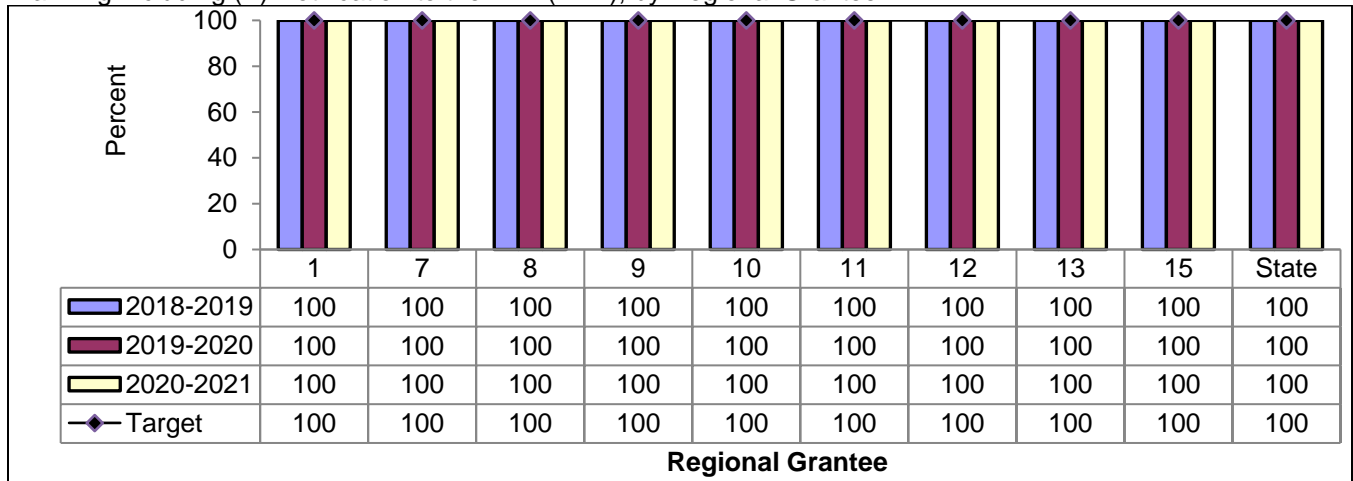

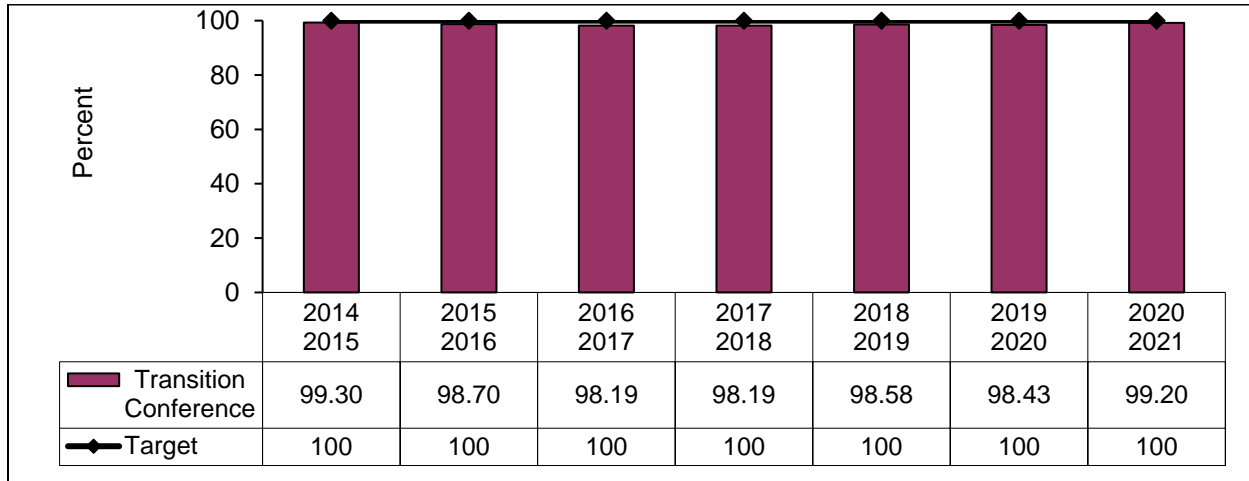

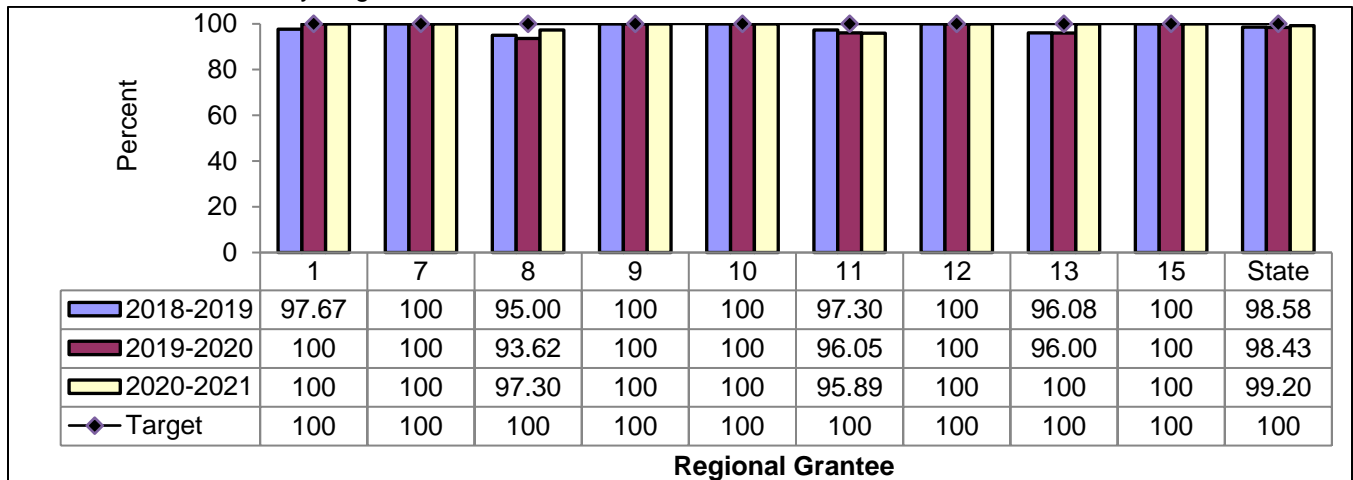
